Subject: Public health risks of proposed 5G rollout in _____ - covering letter

Dear _____,

Please forgive the unsolicited nature of this communication. I am writing as you are a registered elector in _____ Ward / _____ Division of the _____ Constituency, to ask for your help with a campaign being run by the _____ group. We are encouraging local electors to write to their elected government representatives in order to raise awareness of the grave public health threats posed by the proposed rollout of 5G wireless communication technology throughout the United Kingdom.

Following this covering message is a template letter that we are suggesting constituents could send to their elected representatives. If you are able to spare the time to read it and the attached leaflet and maybe watch some of the [5G Crisis Summit documentaries](#), and having done so feel concerned and wish to help, it would be most effective if you could please:

- send the above message individually to each of your elected local borough and county councillors, MP and MEPs as detailed below;
- select the text below the horizontal line at the end of this covering message then copy (Ctrl+C) and paste (Ctrl+V) it into a **new** e-mail (don't just forward this message), **using HTML format** not plain text (otherwise the links won't render);
- delete all inapplicable [options] in the salutation and first paragraph and substitute all the <place-holders> with the relevant details;
- include the attached PDF leaflet as an attachment to your own messages;
- it would help to include me in the **BCC** list when you send the e-mails to your councillors (optional);
- note that it is important the message bears your **address** and **postcode**, as elected representatives only respond to people in their own area;
- it is useful to include your 'phone number(s) (optional);
- it would help to let me know that you have sent messages and subsequently if you receive any substantive response, as it will be useful to the Campaign to track the position of each representative;
- if you have access to a printer, it may be more effective to send hard copies by post (click on representative names below for details);
- **we plan to have messages sent to all elected representatives by 31st October 2019.**
