Introduction


Norwegian Public Health warns against future lockdowns

The Norwegian Institute of Public Health(NIPH), after studying the spread of the virus concluded, in an official report, that the Norwegian outbreak was already slowing at the time the country went into strict lockdown.

Prime minister Erna Solberg admitted "*I probably took many of the decisions out of fear,*" In other words she panicked! Just like our government.

Never before have we placed an entire nation under virtual house arrest. It doesn't make any sense whatsoever. In the past to control an outbreak we

David Spiegelhalter, chair of the Winton Centre for Risk and Evidence Communication at the University of Cambridge, said that covid-19 did not explain the high number of deaths taking place in the community.

At a briefing hosted by the Science Media Centre on 12 May he explained that, over the past five weeks, care homes and other community settings had had to deal with a “*staggering burden*” of 30 000 more deaths than would normally be expected, as patients were moved out of hospitals that were anticipating high demand for beds.

Of those 30 000, only 10 000 have had covid-19 specified on the death certificate. While Spiegelhalter acknowledged that some of these “*excess deaths*” might be the result of underdiagnosis, “*the huge number of unexplained extra deaths in homes and care homes is extraordinary. When we look back . . . this rise in non-covid extra deaths outside the hospital is something I hope will be given really severe attention.*”

He added that many of these deaths would be among people “*who may well have lived longer if they had managed to get to hospital.*”

David Leon, professor of epidemiology at the London School of Hygiene & Tropical Medicine, **agreed**. “*Some of these deaths may not have occurred if people had got to hospital,*” he said. “*How many is unclear. This issue needs urgent attention, and steps taken to ensure that those who would benefit from hospital treatment and care for other conditions can get it.*”



These completely fake studies show just how corrupt and powerful the pharmaceutical industry is!


And the fake studies show just how callous and cold hearted the pharmaceutical industry is!

- vii. There are no huge profits to be made from this old, cheap medication, in contrast to the billions to be made from a vaccine or new drug.



When Chinese doctors recognized the deadly impact of SARS-CoV-2, they began trying known and available anti-viral medicines, especially CQ and HCQ, based on 15-year-old studies. This study from France, of 1061 patients shows the remarkable effectiveness of HCQ. The patients were given HCQ and AZ (an antibiotic)...973 patients fully recovered within 10 days i.e. a cure rate of 91.7%

'Although hydroxychloroquine is not an anticoagulant, this drug is widely believed to have vascular protective effects and prevent the development of thrombotic complications. Dr Malcolm Kendrick a Scottish hospital-based GP, had this to say :-



(A) Testing woefully inaccurate

There are serious problems with PCR testing according to **Dr Claus Köhnlein**, a German Internist co-author of the book *'Virus Mania How the Medical Industry continually invents epidemics, making billion-dollar profits at our expense'*



'The coronavirus test is a PCA-based test, where false positives are programmed in.

Half of the positive tests could be wrong.

PCA tests often show false positives.

You can ask professor Gigerenzer in Berlin about this problem area. The tests are very sensitive. If you have only one molecule of something, the test can show positive. That doesn't mean the patient is sick, or that he has the coronavirus.'

Antibody testing is NOT the gold standard for proving immunity; because our immune systems are incredibly complex and still poorly understood by science.

Antibody screening for example supposedly shows our immunity status but our immune systems don't always make antibodies for every infection that they come across. Some viruses are expelled by T-cells without the need for antibodies. Our immune system merely shrugs the virus off! Recall that 80% of 'infections' are asymptomatic.

It is known that in many cases antibodies, that were used by the body to successfully fight off an infection, will not necessarily still be circulating a few weeks after the infection has gone. So an antibody test would not detect a person's immunity in this case.

Also we have some degree of immunity by virtue of previous exposure to other coronaviruses i.e. the common cold – termed adaptive immunity.

Antibody tests are wrong about half of the time the CDC said in a report published on the 25th of May <https://www.cdc.gov/coronavirus/2019-nCoV/hcp/clinical-criteria.html#otherChanges>

And this is the real problem, many people have coronavirus put on their death certificates on the basis of suspicion of coronavirus. Early on, no tests existed and so doctors diagnosed on symptoms. Symptoms which are, unfortunately common to many diseases – including flu, and pneumonia. . I know of GP's that diagnosed coronavirus by telephone consultation! How the hell can you diagnose coronavirus without even seeing the patient and without an accurate test !

(C) Died 'with' covid NOT died 'from'

We have been hearing the mainstream media say that 'x' amount of people died 'with' covid. Not 'from' covid.

Died 'with' as opposed to died 'from'strange terminology isn't it ?...I'm not just splitting hairs here. This is an important distinction to be made.

What's the difference?

Well supposing Pt A was extremely sick from cancer with perhaps weeks to live and, suddenly took a turn for the worse and died. The cancer killed Pt A.

However the day before Pt A died the nurse tested him for covid-19.

Pt A tested positive for the virus but, it had no real impact on him. He was asymptomatic as far as covid is concerned. The cancer killed Pt A.

But ,that’s right ! - Pt A would be yet another covid statistic – died ‘with’ covid. NOT ‘from’ covid.


In other words the covid was an incidental finding – NOT the cause of death!

Or to put it more bluntly, suppose Pt A tested positive for covid and was asymptomatic. Then he gets knocked down by a bus and dies. What’s the end result?...Died ‘with’ covid. !

Pre-existing conditions are the REAL cause of death

In 95% of deaths people had serious pre-existing disease such as terminal cancer, Alzheimer’s, dementia, heart disease, stroke etc. The most prevalent pre-existing conditions or diseases are dementia and diabetes (a quarter of cases, each), hypertension (a fifth) and serious lung, kidney or heart disease (around a sixth each). In both the UK and Italy, **the average victim had three comorbidities severe enough to be causes of death on a certificate.**

In plain English, the so-called comorbidities are the real cause of death!



Pathologist Dr John Lee wrote an excellent article in The Spectator, essentially the Coronavirus Act 2020 has reduced the number of autopsies significantly. This means that doctors are not finding out much about covid, nor are they finding out therefore, how to treat it. What is worse is the Act removed the necessity for autopsies, which very often shows the cause of death to be different to the suspected cause of death. If they are not doing autopsies how on earth can they verify whether a patient had covid or not?

Dr John Lee went on to say ***‘...very early on in the epidemic, rules surrounding death certification were changed — in ways that make the statistics unreliable.***

Normally, two doctors are needed to certify a death, one of whom has been treating the patient or who knows them and has seen them recently. That has changed. For Covid-19 only, the certification can be made by a single doctor, and there is no requirement for them to have examined, or even met, the patient

For deaths in care homes the situation is even more extraordinary. Care home providers, most of whom are not medically trained, may make a statement to the effect that a patient has died of Covid-19.

*In the words of the Office for National Statistics, this **‘may or may not correspond to a medical diagnosis or test result, or be reflected in the death certification’.***

From 29 March the numbers of ‘Covid deaths’ have included all cases where Covid-19 was simply mentioned on the death certificate — irrespective of positive testing and whether or not it may have been incidental to, or directly responsible for, death. From 29 April the numbers include the care home cases simply considered likely to be Covid-19.

So at a time when accurate death statistics are more important than ever, the rules have been changed in ways that make them less reliable than ever.

In what proportion of Covid-19 ‘mentions’ was the disease actually present?

And in how many cases, if actually present, was Covid-19 responsible for death?

Despite what you may have understood from the daily briefings, the shocking truth is that we just don’t know.

How many of the excess deaths during the epidemic are due to Covid-19, and how many are due to our societal responses of healthcare reorganisation, lockdown and social distancing? Again, we don't know. Despite claims that they're all due to Covid-19, there's strong evidence that many, perhaps even a majority, are the result of our responses rather than the disease itself...

...we have no idea how many of the deaths attributed to Covid-19 really were due to the disease.

And we have no idea how many of the excess deaths were really due to Covid-19 or to the effects of lockdown'

Well, I don't know about you but that leaves me feeling more than a bit cheated by the government propaganda! So the tests are more often than not wrong, and the death certificates are wrong too - we really cannot trust the governments figures at all !

Are they actively trying to make this look worse than it is? Are they actively trying to deceive us? The answer is a resounding YES !

(8) Just how dangerous is covid-19 ?

Well, for most people it's not.

Covid for most people is NOT dangerous. There is a risk to the elderly and the immunocompromised. There is also a risk to smokers and vapers.

The very vast majority of deaths has occurred in elderly people who already had severe diseases. Diseases such as diabetes, cancer, heart disease, Alzheimer's etc

Currently there have been circa 40,000 'covid' deaths.

- **95% of victims dying with covid19 have serious pre-existing conditions!**
- **The average age of those dying of covid19 in the UK is over 80,**
- **About a third are residents of care homes.**


More chance of being struck by lightning !

33 people under the age of 40 years died from covid-19 in England. **Putting that into context - more people get struck by lightning** (on average 49 people get struck by lightning in the UK per annum)

More chance of accidental drowning than dying from covid if you are under 60 and healthy! Around 400 people die from drowning annually in the UK – far more than the ‘healthy’ 253 people under 60 years who unfortunately died from covid-19 in hospital.

The very vast majority of healthy people are NOT at any significant risk.

So why not just isolate the high risk group i.e. care homes , the frail and the very elderly. AND LET THE REST OF US GET ON WITH OUR LIVES AS NORMAL



I'll let Chris Whitty Chief Medical Officer explain just how 'dangerous' covid is :-

on the 11th May he said ...

*'The great majority of people will not die from this and **I'll just repeat something I said right at the beginning** because I think it's worth reinforcing:*

Most people, a significant proportion of people, will not get this virus at all, at any point of the epidemic which is going to go on for a long period of time.

Of those who do, some of them will get the virus without even knowing it, they will have the virus with no symptoms at all, asymptomatic carriage, and we know that happens.

Of those who get symptoms, the great majority, probably 80%, will have a mild or moderate disease. Might be bad enough for them to have to go to bed for a few days, not bad enough for them to have to go to the doctor.

An unfortunate minority will have to go as far as hospital, but the majority of those will just need oxygen and will then leave hospital.

And then a minority of those will end up having to go to severe end critical care and some of those sadly will die.

*And even in the highest risk group this is significantly less than 20%, **i.e.. the great majority of people, even the very highest groups, if they catch this virus, will not die.***

In a recent analysis, (published 19th May) Stanford epidemiologist John Ioannidis, MD estimated the IFR (Infection Fatality Rate) for COVID-19 at between 0.02 percent and 0.4 percent. *"While COVID-19 is a formidable threat,*




If covid is so dangerous how come two members of SAGE ignored their own advice?

Neil Ferguson and Dominic Cummings both instrumental in SAGE and pivotal in forcing the country to lockdown have been caught breaking their own advice.






Well then, why send flu / covid ridden people to vulnerable people in care homes !!!




Children need to play and interact with other children, it's essential for their development and wellbeing. In any case, the idea that we can – or should - force school children to social distance is laughable and contemptible.



(16) Did the government use scare tactics to create panic in order to exert control over the public

Even when they did finally release the SAGE minutes they were found to be heavily censored. Even names of people attending the meetings have been redacted




The names of SAGE panel members blacked out. Why?

In other words, SPI-B recommended to SAGE, that levels of fear needed to be increased, in order to improve compliance with social distancing.


They further recommend that the media is used:

Professor Carl Heneghan, the director of the Centre for Evidence-Based Medicine at the University of Oxford said that **the peak was March the 18th** and this meant that we locked people up in their homes who had already contracted the virus - bear in mind the incubation period is up to eleven (11) days, and people took on average ten (10) days to die following the incubation period. Peak deaths was on April the 8th so subtracting 21 days leaves the peak of infection on or around March the 18th.

The majority of hospital admissions were of people who were already self-isolating. This alone demonstrates that people were already infected before lockdown.

Virus disappearing faster than vaccine manufacturers can move


The covid virus is disappearing so rapidly that by the time any vaccine is ready the disease will have already blown itself out.

It's a race against the virus disappearing, and against time," said Professor Hill

'We said earlier this year that there was an 80% chance of developing an effective vaccine by September.'

"But at the moment, there's a 50 per cent chance that we get no result at all.

"We're in the bizarre position of wanting Covid to stay, at least for a little while. But cases are declining."



In fact the virus has GONE !

So there you have it ! The experts are saying that the virus has gone!



“The ferrets developed to all four vaccines an admirable immune response. The scientists thought they hit the jackpot. ...

“Vaccines are never tested in the field. The FDA never gives 2,000 people a vaccine and 2,000 people a placebo and says go out in the world and see what happens. That never happens.

“The way vaccines get a license is the promoter of the vaccine, the company, injects a couple thousand people with the vaccine and then they test their blood to see if they develop an antibody response.

“The ferrets developed a picture perfect antibody response, so they all thought they hit the jackpot. Then something horrible happened.

“When those ferrets were later exposed to the wild virus, they all had body wide inflammation in all their organs, and they died.

“The scientists then remembered something. They remembered that in the 1960s, the FDA and NIH had tested an RSV vaccine which is very similar to corona virus. ...They had skipped animal studies and they had gone right to humans. They had tested on 35 kids.

*“The kids again developed a sterling antibody response, so they thought they hit the jackpot. But when those children were exposed to the wild virus, instead of protecting them against it, **the vaccine actually enhanced the pathways of the virus.** Two of those kids died. They all became horrendously sick. It became a scandal and they dropped it and never touched it again. ...*

“The corona virus does something interesting when it provokes the antibody response. There are two kinds of antibodies. There are neutralizing antibodies which are the kind that defend you from disease. There’s another kind of antibody called a binding antibody that actually helps the virus stick to your receptors and it makes it much, much more dangerous. That’s the kind that is produced by the coronavirus vaccines. That was in 2012 and they completely terminated the program.

They should be looking at the vaccine industry with an impartial viewpoint. They should not be in bed with them !!!!


Well why shouldn't the government be in bed with the vaccine industry, I hear you cry. Surely the vaccine science is settled ?

US Government study (January 2020, Vaccine)

The odds of testing positive for individual respiratory viruses by vaccination status were also examined (Table 5). The influenza vaccine was sufficient at protecting all influenza virus results tested for at a significant level except two (Influenza B Victoria and Influenza coinfections) (Table 5). Both Influenza B Victoria and Influenza coinfections had reduced odds in the vaccinated cohort, but not at significant levels (Table 5). Examining non-influenza viruses specifically, the odds of both **coronavirus** and human metapneumovirus in vaccinated individuals were significantly higher when compared to unvaccinated individuals (OR=1.36 and 1.51, respectively) (Table 5). Conversely, all other non-influenza respiratory viruses had decreased







Mobile phone radiation is considered dangerous to health by the vast majority of scientists and doctors in this field. 

Yet now the ICNIRP say that RF is safe! **ICNIRP is considered to be completely untrustworthy by the vast majority of doctors and scientists.**





(21) Are there two diseases going on? Virus and RF ?






Figure 3-3 MU beamforming accurate coverage

BIOLOGICAL EFFECT OF MILLIMETER RADIOWAVES

[Text] Morphological, functional and biochemical studies conducted in humans and animals revealed that millimeter waves caused changes in the body manifested in structural alterations in the skin and internal organs, qualitative and quantitative changes of the blood and bone marrow composition and changes of the conditioned reflex activity, tissue respiration, activity of enzymes participating in the processes of tissue respiration and nucleic metabolism. The degree of unfavorable effect of millimeter waves depended on the duration of the radiation and individual characteristics of the organism.

The ubiquitous propagation of radiowaves, radio broadcasting and television contributing to the appearance of a new physical factor -- electromagnetic

The conducted investigations showed that the irradiation of animals by millimeter waves caused changes of the processes of oxidative phosphorylation in the liver, kidneys, heart and brain of the animals. The irradiation inhibited the oxygen consumption rate by the mitochondria of those organs in the active phosphorylating state and slowed down the rate of respiration upon exhaustion of the ATP. 

The power flux density sometimes reached $1,000 \mu\text{W}/\text{cm}^2$. A total of 30 people (average age, 35), who had no contact with ultra-high frequency energy in their practical activity, constituted the control group. All the examined people were under observation for 3 years and during winter months (December-February) underwent a periodic medical and biological examination.

Workers servicing ultra-high frequency generators complained of fatigue, drowsiness, headaches and loss of memory. The body temperature was normal throughout the period of examination. The changes in the pulse and arterial pressure did not exceed the limits of physiological fluctuations. During a study of the morphological composition of the peripheral blood in individuals servicing ultra-high frequency generators a decrease in the amount of hemoglobin and in the number of erythrocytes, a drop in the color blood index and a tendency toward hypercoagulation were observed. A variational-statistical processing of results showed a significant drop in these indices. An analysis of the white blood picture showed that under the effect of radio waves there was a significant change in the total number of leukocytes (from $4.71 \pm 0.33 \cdot 10^3$ to $4.10 \pm 0.60 \cdot 10^3$ per μl with $5.98 \pm 0.21 \cdot 10^3$ in control) and lymphocytes (from $30.3 \pm 1.20 \cdot 10^3$ to $37.8 \pm 1.13 \cdot 10^3$ per μl with $22.9 \pm 1.62 \cdot 10^3$ in control) and the number of segmentonuclear neutrophils decreased by 20%. At the same time, the number of reticulocytes and thrombocytes was reduced and the osmotic resistance of erythrocytes decreased by 18% and the acid resistance, by 26%. Thus, a pronounced reaction on the part of the blood appeared under the effect of radio waves of a millimeter frequency range, but the changes that appeared were noted for instability.

5G lowers immunity

In the same paper they state *'irradiation with radio waves of a millimetre frequency range resistance to infection induced with typhoid culture was lowered by 40%'*

Err.... So that's decreased oxygen uptake by our cells , blood clots and increased infections!!! 


You may well ask why am I referring to 1970's research from Russia. Well, alarmingly 5G has not been safety tested, and yet they are rolling out 5G everywhere.


Communist Party of China spying on us !


Legal challenges


(22) Track n trace

When solicitors tell you that they won't be downloading the track n trace app it's time to start considering the implications. The right to a private life is one human right which is being infringed here. But it is also concerning that the tracking could be used to wrongly link you to crimes.

Shockingly, data is going to be stored for twenty years which according to Ravi Naik, a data privacy lawyer

He added **clauses on who could work with the test and trace data were "dangerously vague"**.





Immunity passports will likely be a QR code on our phones initially or it could soon be embedded in a wearable device such as a bracelet.


Quantum dot tattoos


The death toll is no doubt massively overestimated. Lockdown killed way more people than it was supposed to save.


Fourth Industrial Revolution – Artificial Intelligence

Consult with a herbalist, naturopath , homeopath etc for more advice


- (ii) Hardwire your house – get rid of the wi-fi
